# Can-Am Days Game 2025 – BRP BY ADVENTURE FULL REGULATIONS

– DRAW NO. 51707 – FROM 11 APRIL 2025 TO 27 APRIL 2025

## **Article 1: Game-organising company**

The company BRP France, with a capital of €100,000, with headquarters at Route de la Côte d'Azur, 13 590 MEYREUIL, France, registered under the French Trade and Companies Register (RCS) No. Aix-en-Provence B 482 596 533 (hereinafter referred to as the "Organising Company") is organising a Game without purchase obligation from 11/04/2025 to 27/04/2025 [11:59 PM] (inclusive).

# **Article 2: Participants and eligibility**

This Game without purchase obligation is exclusively open to adults residing in mainland France (including Corsica and Monaco), Germany, Austria, the Netherlands, Belgium, Luxembourg, Italy, Spain, and the United Kingdom.

Persons who do not meet the above conditions are excluded from the Game, as well as employees of the Organising Company, and anyone who has directly or indirectly participated in the design, implementation, or management of the Game, as well as their spouses and family members: this includes direct ascendants and descendants or other relatives whether or not they live under the same roof.

The Game is limited to one entry and one prize per person (same first name, same surname, same postal address, same email address) or per company name (same surname/company name, same address, same email) for the entire duration of the Game.

The Organising Company reserves the right to ask any participant to prove their compliance with the above conditions. Any person who does not meet these conditions or refuses to prove their compliance with them will be excluded from the Game and, should they win, will not be able to claim a prize.

Participation in the Game implies full acceptance of these rules.

## **Article 3: Entry methods**

**STEP 1: Visit** a dealership near you between 11/04/2025 and 27/04/2025 and **scan** the QR code available at the dealership.

#### STEP 2: REGISTER online no later than 27/04/2025 (11:59 PM)

- Enter your personal details (first name, surname, postal address, email, phone number)
- Select your place of purchase
- VERIFY your registration and immediately find out whether you won a prize

Any prize that is won is to be collected immediately at the dealership.

Once you have entered, you will be automatically entered into the draw that will take place on 21/05/2025 to try to win 1 (one) of the 4 (four) BRP vehicles up for grabs.

Any entry that violates the provisions of these rules will render the entry invalid. Any participant suspected of fraud may be excluded from the Game by the Organising Company without the Organising Company having to justify itself. # Any prize that is won is to be collected immediately at the dealership.

Winners will be selected by an open instant-win system that is spread throughout the duration of the Draw. Each instant win corresponds to one prize.

If the entry corresponds to one of the instant wins, the participant then wins the prize available for that instant win. Instant wins are programmed by computer before the start of the Game and are spread throughout the period of the Game.

#### 4.2: Prize draw

4 (four) BRP Can-Am Mini Renegade vehicles, with a maximum unit value of €4,900 / £5,300 / 50,800 kr incl. VAT.

The vehicle registration card and start-up costs are included in the prize. However, the rest of the vehicle's operating costs (fuel, insurance, maintenance, etc.) are the responsibility of the winner. On the day the Vehicle is given to the winner, they must present a valid insurance certificate proving subscription to vehicular insurance for the Vehicle won.

The Organising Company reserves the right to extend, shorten, modify or cancel the Game at any time, particularly in cases of force majeure, without participants being able to claim any compensation. Any rules modified by amendment(s) will be filed, if necessary, with SAS AIX-JUR'ISTRES.

## **Article 8: Industrial and intellectual property**

The reproduction, representation, or exploitation of all or part of the elements of the Game and these rules is strictly prohibited.

All trademarks, logos, texts, images, videos, and other distinctive signs reproduced on the Game site and on the sites to which it provides access via hypertext links are the exclusive property of their holders and are protected as such by the provisions of the French Intellectual Property Code and worldwide. Unauthorised reproduction constitutes infringement liable to criminal prosecution.

## **Article 9: Liability**

The Organising Company shall not be held liable in cases of force majeure or unforeseeable circumstances.

The Organising Company shall not be held responsible for delays, losses, theft, damage to deliveries, or illegibility of postmarks due to postal services. It shall not be held responsible and no recourse may be taken against it in the case of events characteristic of force majeure (such as strikes, bad weather) which partially or totally deprive participants of the opportunity to participate in the Game and/or the winner of receiving their prizes.
